The Company has, on Saturday, February 11, 2023, completed dispatch of the Postal Ballot Notice dated February 3, 2023 seeking approval of the Members of the Company by e mail only to the Members whose names appear in the Register of Members / List of Beneficial Owners as received from National Securities Depository Limited ("NSDL"), Central Depository Services (India) Limited ('CDSL') and TSR Consultants Private Limited, the Company's Registrar and Transfer Agent ('RTA') and whose e-mail addresses are available with the Company as on Friday, February 3, 2023 ("Cut-off date"). The voting rights shall also be reckoned on the paidup value of shares registered in the name(s) of the Members as on the Cut-off date. Accordingly, a physical copy of the Notice along with Postal Ballot form and prepaid business reply envelope, have not been sent to the Members for this postal ballot.

The Company has engaged the services of NSDL for providing remote e-Voting facilities to the Members, enabling them to cast their vote electronically and in a secure manner. The remote e-Voting shall commence on Sunday, February 12, 2023 at 9:00 a.m. (IST) and shall end on Monday, March 13, 2023 at 5:00 p.m. (IST). Members are requested to record their Assent (FOR) or Dissent (AGAINST) through the remote e-Voting process not later than 5:00 p.m. (IST) on Monday, March 13, 2023. During this period, Members of the Company holding shares either in physical or electronic form, as on the Cut-off date, shall cast their vote electronically. 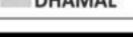
